# 7.1 Bruce County Safe Communities Committee

Jason Weppler and OPP Sergeant Marla Barfoot gave a presentation to Council. Their goal is to make Southern Bruce County a safe place to live. Bruce County officially designated as the 69th safest Community in Canada and were presented with the "Key to Safety".

Lower tier municipalities are be mandated to have a plan in place by January 1, 2021. The Bruce County Safe Communities are able to support the municipality in preparing this plan. They are asking each municipality to assign a staff person. Arran-Elderslie has already appointed Councillor Kanmacher and Recreation Manager Carly Steinhoff. The group has a Facebook page and Twitter and Instagram feeds.

Council thanked Mr. Weppler and Sergeant Barfoot for their presentation.

## 7.2 Tenzing – Business Expansion & Enhancement Strategy for Paisley

The representatives from Tenzing gave a presentation to Council in regards to Business to Bruce: Paisley - Business Needs Analysis and Strategy. Tenzing builds brands for companies and municipalities. Paisley's business brand will be "express your talents".

They prepared a situational audit for Paisley. The group noted that the Community lacks scale, but has a large talent pool. There are closing businesses, housing shortages and the downtown is showing wear and neglect.

The municipality must be willing to jump in and work with the business owners.

Council thanked the representatives for their presentation.

## 7.3 Tara Legion – Street Name Change Request

Brenda Funston made a presentation to Council regarding a street name change in Tara. The legion would like to change Main Street which starts at the cenotaph. They would like to change it to "Veteran's Way".

The other option is to have an additional sign so that the street name is not actually changed.

Works Manager Scott McLeod said that there should be separate signs rather than changing the street name. If the name were to be changed, the residents should be polled prior to the change.
