A meeting of the Council of the Municipality of Arran-Elderslie was held on Monday, September 23, 2019 at 9:00 a.m. in the Council Chambers.

1. Adoption of Agenda

7. Delegation(s) -

7.1 Former Mayor Ron Oswald thanked Council and especially Councillor Bell for putting the family name forward for the new bridge in Chesley. He also thanked Mayor Hammell for taking it forward to Bruce County Council. He said it was an honour to have the bridge named after his family.

7.2 Ron Nickason – Road Agreement

Mr. Nickason spoke to Council about his land development in Allenford. He had plans to sever to some lots and he agreed to build a road from the end of Nickason drive to Sideroad 25. He wanted to deal with the road superintendent and instead of an engineer. He feels this is not feasible. He would now like to merge the lots and not construct a road.

Mr. Nickason's planner, Don Scott, stated that the Bruce County planning department noted that this was not consistent with the PPS. The zoning would permit another house with a severance. Mr. Nickason's shop has been relocated to Tara and it is not viable to build the road. It would require the removal of the one-foot reserve from Nickason drive and would also require having the Holding designation removed from the lots. It would be a good idea to extend the road from Nickason Drive to Sideroad 25 as there is only one entrance/exit.

Mr. Scott asked if there would be interest in cost sharing with the construction of the road.

Works Manager Scott McLeod noted that he is disappointed that the road is not going to be constructed as there is only on access. It would be an asset to the municipality.

Councillor Greig noted that his worry is that the road construction is put on the Works Manager rather than the engineer. This is a liability issue.

Deputy Mayor Davis noted that there are no other subdivisions that have one access over a bridge. A secondary road is extremely important.

Councillor Bell asked if the people that live there would like to see the road developed. He agrees with Deputy Mayor Davis that someday that bridge will need to be repaired and a new road would be good for emergency vehicles.

Councillor Dudgeon asked if the Municipality needs to consult with the Planning Department to see what the next steps are.

7.3 Colleen Madill - Minor Soccer

Soccer shares space with baseball and they need use of the big field. They would like to work together or look for more space.

Youth and adult teams use the field. Parking is also an issue. They cannot run tournaments as there is not enough space. They are looking for guidance and Council support.

Councillor Grieg noted that he had contacted the Lallemand executive

and they own the land that is adjacent to the soccer/ball field. They have some interest in leasing the land and moving the soccer field to that area. Baseball would take up the space where soccer is currently.

Recreation Manager Carly Steinhoff noted that some work was completed on Diamond 2, but soccer only received new nets. It is also a safety issue when both sports are running concurrently. Chesley has about 100 participants in their league and Paisley is starting soccer.

Deputy Mayor Davis asked if there is a record of where the participants live.

Councillor Bell asked if they were looking for financial support from Council. He will not support any funding from Council.

Council instructed the recreation manager to bring a report back to Council regarding next steps.

8.1.1 Township of Warwick – Enforcement of Safety on Family Farms

WHEREAS agriculture is the second largest industry in Ontario, contributing \$13.7 billion annually to Ontario's GDP and is essential for putting food on the tables of millions of people here and around the world;

AND WHEREAS in recent months there has been a steady increase in harassment of farmers and livestock transporters by activists opposed to animal agriculture and the consumption of animals;

AND WHEREAS the protests have become blatantly illegal in nature with extremist groups trespassing onto private property, unlawfully entering into buildings and removing animals without fear of prosecution and even promoting and publishing their crimes on social media;

AND WHEREAS maintaining proper biosecurity is essential to ensure the health and well-being of the animals cared for on these agricultural operations;

AND WHEREAS the recent attacks on farmers homes and businesses have resulted in no criminal charges laid, leaving farmers feeling unprotected by the Ontario legal system and afraid for the welfare of themselves, their families, their employees and the animals they care for;

NOW THEREFORE BE IT RESOLVED THAT the Council for the Corporation of the Municipality of Arran-Elderslie requests that Hon. Bill Walker to work with his fellow MPP's and agricultural leaders to find a better way forward to ensure stronger enforcement of existing laws or new legislation - to ensure the safety of Ontario's farm families, employees and animals;

AND BE IT FURTHER RESOLVED THAT this motion be circulated to Hon. Bill Walker, Ministry of the Attorney General, Hon. Doug Ford, Premier of Ontario, Hon. Sylvia Jones, Solicitor General and Hon. Ernie Hardeman, Minister of Agriculture, Food and Rural Affairs.
