Whereas Ontario farms have increasingly come under threat of unwanted trespassers and activists who are illegally entering properties, barns and buildings, seizing private property and threatening the health and safety of farms, employees, livestock and crops. This has resulted in farmers, their families and employees becoming increasingly frightened and frustrated; and

Whereas these activities are causing serious threats to the mental health and wellbeing of Ontario farmers. Farmers and their families live on their farms, making this ongoing threat even greater, exposing families to perpetrators and causing a concern for personal safety, safety of farm families and employees as well as biosecurity.

Therefore, the Council of the Municipality of Arran-Elderslie supports Bill 156 - Security from Trespass and Protecting Food Safety Act, 2019, to protect farms and food safety and allow farmers to operate their businesses without the fear of special interest groups and activities attempting to disrupt their farms, families and way of life with no legal repercussions.

And further that a copy of this motion be sent to the Ontario Minister of Agriculture, Food and Rural Affairs, the Honourable Ernie Hardeman, MPP Bill Walker, and the municipalities of Grey and Bruce Counties.
